In addition to building an interfaith community, ICP is designed to engage religious diversity and to widen participation in interreligious activity, education and skill across each geographic context. During the fiscal year, Shared Sacred Spaces implemented a scaled, volunteer-driven model, giving it the ability to develop volunteers as interfaith leaders, coach and grow localized and sustained leadership, and bring the program to a greater number of people.
